Vice Commodore Report

days we have had a few slip request cancellations which will enable us to move a few boats from the kegs. As soon as possible the changes will be posted on the dock chart.


Any boats on I Pier not yet launched will be moved to a storage area.

Masts placed in the rigging area must be kept in the designated area and must not block access to catwalks to the nearby boats.

Temporary use of assigned slips for boats fitting out must have the concurrence of the assignee and the Vice Commodore Dockmaster must be informed. The temporary user must move out as soon as fitting out is completed or at the assigned slip holder's request. Unauthorized use of a slip or a keg is cause for disciplinary action. Slips that are vacant when the assigned user are out will be used by the Club for visitors from other Clubs, a courtesy that we expect when visiting other Clubs.

Members are advised to review the rules governing co-owners of boats.



Everyone seems pleased with the new lighthouse; however, this was not due to any one person's efforts. Below, to date, are the people who lent their ideas, time,



The wife of one of our members had a coat stolen from the cloak room in the Club on February 25th. The member and his wife are extremely irritated by this action and have directed a well spoken letter to the Board of Directors expressing their feelings.

The Board reviewed this letter at the regular March meeting, concluding the following: A member, (or one of whose family), caught stealing on Club property will be expelled. The Club will encourage and participate in, if necessary, any legal action taken by the victim against the thief. Thieves are forewarned that the authority of the Board to take such drastic action is far more encompassing and assured than that of government enforcement officials who are often frustrated by the "reasonable doubt" plea of defendents attorneys. As stated in the member's letter to the Board "the Erie Yacht Club is not a smoke filled dive" and most certainly this Board intends to make sure it does not become such. Punishment for misconduct will be quick and severe.

A member may not evade the misconduct of his guest, while on Club property as the Club rules clearly require that each member is responsible for his guest and shall be with him or her while the guest is on the property.

The Board fervently hopes that no misconduct situation shall arise which would force them to take action but this Board shall resolutely do so if necessary.

- New Rules of the Road -

A major change has occured (March 1, 1983 on the Lakes) in the laws regarding the operation of boats. These changes involve sound signals, right of way between vessels and lighting requirements. Even for those of you who had been well versed in the intricacies of the previous rules, it will become necessary for you to re-orient yourselves to a new nomenclature and some decidedly new rules.

First, the four sets of Rules (International, Inland, Great Lakes and Western Rivers) have been reduced to two, International and Inland, with further progress toward a single Rule scheduled for June 1, 1983. The present Rule, International and Inland are published in a single booklet indentified as COMDTINST M16672.2 available from the Supt. of Documents, U.S. Government Printing Office, Washington, D.C. 20402 for \$6.50. I sent for mine on February 18th, receiving a notice on March 31st that the Supt. was waiting for a new printing. I'm still waiting as of April 25th. However Tom Collman got his copy at the U.S. Government office in downtown Cleveland.

Secondly, the measuring methods have changed. We use meters instead of feet with the following dividing lengths:

Vessels less than 7 meters (23. feet)

Vessels less than 12 meters (39.4 feet)

Vessels less than 20 meters (65. feet)

Also, such terminology as two points abaft the beam will be abandoned in favor of a definition in degrees, i.e. a light showing from two points abaft the beam on each side now becomes a light showing 25 degrees.

In future sections of this report I will attempt to describe the new rules with report to "Lights", "Sound Signals" and "Right of Way" as they apply to small boats, presuming I get my official copy of the Rules. While there are more changes than will be covered in these reports, many are not applicable to the kinds of boats we sail and will be included only if pertinent to your needs.
